SolidWorld Group concludes agreement to supply a robotic cell to be made in China

SolidFactory, a newly formed company of the SolidWorld Group, arrives on Asian soil and will equip a production line at the Chinese plant owned by an Italian company.

Treviso, March 16, 2023 - SolidWorld Group S.p.A. has concluded an agreement to supply a robotic cell to be installed at the Chinese base of a well-known Italian company specializing in the development and production of hot runner systems for the injection molding industry.

SolidFactory S.r.l., a Solidworld Group S.p.A. company established about a month ago, thus arrives in Asia and will install this production line at a plant located in China. It will be a turnkey supply, with SolidFactory building the complete production line on behalf of the customer, who can then use it for their operations. SolidFactory's is an "industrial contractor" for the installation of high-tech and digital production lines for its customers.

This major order was achieved thanks to the high level of specialization in providing digital automation systems for production processes, integrating a robotic solution for loading and unloading machine tools.

The cell, with 7mt by 8mt dimensions, will be able to communicate with the production management system and, in a fully automatic manner, will manage the production stages by loading the semi-finished product into the warehouse in the machining center and then, once the processing is finished, picking it up, performing quality control, automatically marking the product code and then depositing the finished product in the relevant storage warehouses.

The anthropomorphic robot will be able to autonomously change the gripping tools and spindle configuration of the machining center according to the production order, while the minimal presence of the operator ensures automatic unmanned 24-hour production. Plant efficiency reduces average production cycle time by 40% while ensuring consistent quality.

Throughout the processing and handling process, it will be possible to monitor production data so as to make the process itself more efficient.

"For us, it is an honor and an opportunity for growth to be able to contribute to the digital improvement of the production processes of a major and world-renowned company. The preparation and skills of SolidFactory's technicians have been the secret to studying and providing a highly-automated and digitized solution that will make it possible to make production lines more efficient by monitoring work phases in a timely manner" stated Solidworld Group S.p.A. Chairperson Roberto Rizzo, who is confident of the strategic importance of the digital automation of industrial processes and is aware that, with the creation of SolidFactory, the Group's latest

company, a key operation has been concluded to serve industrial production chains for the installation of highly technological systems and software for the digital management of production data.

***SolidWorld Group S.p.A.** is the parent of a group of 11 companies founded in the early 2000s by engineer Roberto Rizzo. Listed on the Euronext Growth Milan segment, the Group is a leading developer and integrator of the latest and most comprehensive digital 3D software and hardware for manufacturing companies, supporting and accelerating their journey to Industry 4.0.
